WELCOME TO THE BASIN - SOPHIA SIGSTEDT, LYNKER TECHNOLOGIES

With the lack of in person meetings, it's hard to get to know newcomers to the Rio Grande Basin Roundtable. We'd like to remedy that by introducing Sophia Sigstedt! Sophia is a hydrogeologist and consultant with Lynker Technologies and grew up in northern NM, spending a lot of time in San Luis Valley as a kid. She studied the San Luis Valley under Dr. Fred Phillips at the New Mexico Institute of Mining and Technology where she earned her masters degree in Hydrology. Sophia specializes in basin-scale water resources and hydrogeology, currently working with groundwater modeling and water rights work. Sophia brings extensive experience in the Rio Grande Basin, as she was mentored in conjunctive administration of surface and groundwater rights by Dr. Chuck Brendecke, who did water rights work in the Conejos Basin.

Sophia loves rock climbing, camping and fishing, skiing in the winter and open water swimming in the summer. She's a self professed country kid who grew up with lots of land and animals like donkeys, ducks and pheasants, next to a river with springs to drink and watercress to pick, swimming holes, and train tracks. KEVIN TERRY - RECREATION REPRESENTATIVE



Kevin Terry is a fisheries biologist born and raised in northern New Mexico with a fly rod in his hand. After attending Oregon State University and receiving a bachelors in Fisheries Science, Kevin moved to Colorado. Kevin and his wife Stephanie are raising their twins on the banks of the Rio Grande where Kevin is working for the Western Water and Habitat program of Trout Unlimited. In his role, Kevin splits his time working to protect and restore populations of the native Rio Grande Cutthroat trout and working within the water community to strategically identify and implement water transactions for in-stream flows with ecological benefits while simultaneously providing water and services to farms and ranches of the San Luis Valley. He also provides expertise for local youth environmental education. Kevin is the recreational representative to the Rio Grande Basin Roundtable.

LOCAL PROJECTS GREEN LIT BY COLORADO WATER CONSERVATION BOARD

Projects approved by the Rio Grande Basin Roundtable were given an additional necessary stamp of approval by the Colorado Water Conservation Board of Directors at their March 12, 2020 meeting in Denver. These projects included Colorado Open Lands' Schaefer Farm and Jackson Ranch Conservation Easements, Rio Grande Watershed Conservation & Education Initiative's Roundtable Community Education Staff Liaison, Terrace Irrigation Company's Outlet Works Repair, and Cenicero Ranch assessment.

IN MEMORY OF JEANNE "GIGI" DARRICADES

The Rio Grande Basin Roundtable wishes to extend condolences to Mike Gibson, Roundtable member, and his family and friends as they experience the passing of Mike's wife, Gigi Darricades.

Gigi died peacefully in Alamosa after a long battle against an incurable cancer. Gigi spent her life working on the front lines of rural healthcare, beginning in New Mexico, where she met the love of her life, Mike. Gigi and Mike moved to Utah and Wyoming before moving to Colorado - and eventually, to the San Luis Valley in 2000. Gigi not only practiced health care law, but practiced environmental law and was an expert in land conservation law. She represented the Rio Grande Headwaters Land Trust as well as numerous private landowners, before becoming the CEO and President of Valley-Wide Health Systems in 2011. She was honored as the CHAMPS 2018 Stanley J. Brasher Legacy Award for her dedication to solving the problems of health, poverty, and human rights. March 6, 2020 was declared "Gigi Darricades Day" by the organization. Gigi served on numerous boards in the community including KRZA community radio, SLV Immigrant Resource Center, Adams State University, and SLV Federal Bank. She also supported many non-profits, including the Rio Grande Headwaters Restoration Project, RiGHT, SLV Animal League, La Puente, and the Boys & Girls Club. Gigi leaves behind her beloved husband, family, and friends across the world, but the world itself is a better place for having had Gigi in it.
